## A Message from Attorney General Kwame Raoul

The holiday season is here once more and with it, the rush of holiday shopping. Whether you will be visiting businesses in your community or taking advantage of the convenience of online shopping, it is important to be aware of hazardous toys, clothes and other children's products that have been recalled throughout the year. If you have a child on your shopping list, I recommend checking my office's annual Safe Shopping Guide to be informed of the dangers associated with some children's products – and to avoid purchasing an item that has been recalled.



This year, the Safe Shopping Guide highlights nearly 100 recalls issued by the U.S. Consumer Product Safety Commission during 2022. Descriptions of the toys, furniture, children's clothing and other children's products are accompanied by photographs to make hazardous products easier to identify. Descriptions also include actions families can take if they already have any of these products in their homes.

Electronic items top the wish lists of many children and youths, and I urge parents and guardians to exercise caution before purchasing products, such as e-bikes, headphones and other toys, that use batteries. The guide highlights a number of these products that use batteries, which can overheat, ignite and pose a fire hazard. Other products, such as e-bikes, have been recalled for malfunctions that cause batteries to fall out unexpectedly, potentially causing a hazard to the child using it. The guide also describes toys, electronic key fobs and other non-toy items powered by small button batteries. Curious children can ingest or insert those batteries in noses and ears, resulting in serious burns.

I am also urging families to be aware of recalled toys with parts that can break off and become choking hazards, or which contain levels of lead or other harmful chemicals that can result in poisoning or skin irritation. The guide also includes children's clothing that does not meet flammability standards or that poses strangulation hazards. It is particularly critical that parents, grandparents and guardians are aware of products including bunk beds that pose entrapment and strangulation hazards, which can result in serious injuries or death. In addition, the guide highlights toys and products for older children, such as youth all-terrain vehicles and safety helmets that do not meet safety requirements, posing a risk of serious injury or death.

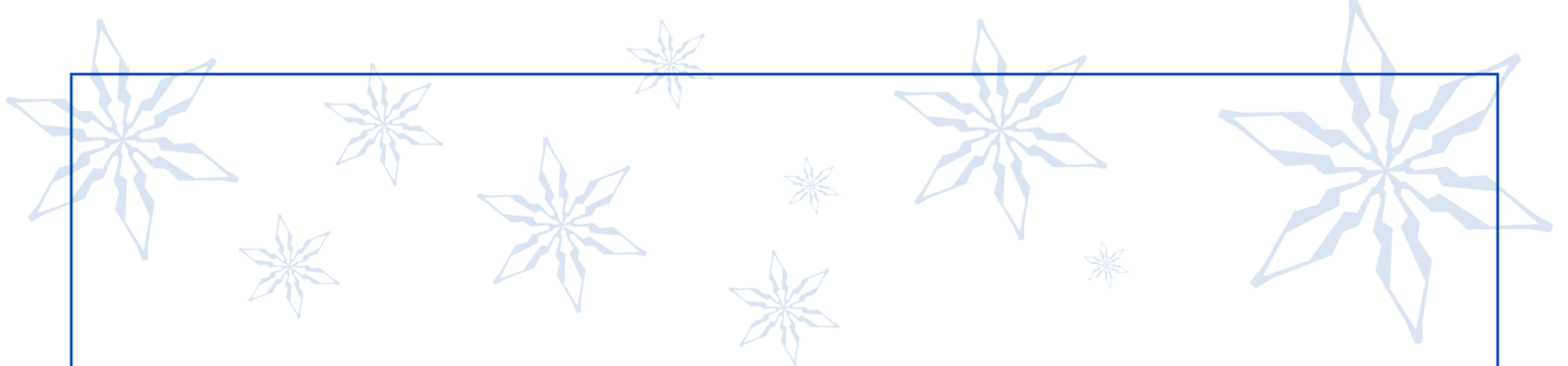
Even though recalled products should not be sold, families should ensure they do not have these items in their homes. As shoppers visit secondhand websites, they should be aware these products may still be available, making it particularly important that shoppers check the guide before shopping. Information in the guide can help you avoid purchasing toys or items that could harm a child you love. Recalls from December 01, 2021 through October 20, 2022





**Dec. 1, 2021: HALO Recalls Promotional Children’s Projector Flashlights Due to Button Battery Ingestion and Choking Hazards**

A child can disassemble the projector flashlight and access the button cell batteries, posing ingestion and choking hazards. The recalled flashlights were part of a Disney-branded care package that also includes a tote bag, silicone wristband, playing cards, ink pen, journal, wall decals and a set of postcards. Consumers should immediately take the recalled projector flashlight away from children, stop using it, and



contact HALO for a full refund and a prepaid shipping label to return the projector flashlight.

Upon return, HALO will send the consumer a \$5 gift card redeemable at a major national retailer. **Dec. 10, 2021: Target Recalls Decorative Mailbox Due to Laceration Hazard.**

The mail slot on the mailbox can be sharp, posing a laceration hazard. Consumers should immediately stop using the recalled mailbox, and return it to any Target store for a full refund in the form of a Target gift card. Consumers can also contact Target to receive a prepaid return label to return the mailbox for a full refund in the form of a Target gift card. **Jan. 6, 2022: Colony Brands Recalls Children’s Wood Wagons Due to Violation of Federal Lead Paint Ban and Lead Poisoning Hazard.**

Paint on the wood wagons, the plastic handles and the red plastic cover contain levels of lead that exceed the maximums allowed. Excessive levels of lead can be toxic or cause other health problems to young children if the paint is ingested.

Consumers should immediately take the recalled wagons away from children and return them for a full refund. The involved retailers are contacting all known purchasers to arrange returns and are providing prepaid shipping labels and return instructions. Consumers will receive a full refund once the recalled product is returned. **Feb. 2, 2022: Games Workshop Recalls Koyo Bounca The Squig Plush Toys Due to Choking Hazard.**

The pompoms can detach from the toy, posing a choking hazard to young children. Consumers should immediately take the recalled plush toy away from young children, and return the toy to any Games Workshop or Warhammer store for a full refund. **Feb. 9, 2022: Stack Em’ Up Books Recalls Children’s Stackable Toys Due to Violation of the Federal Lead Paint Ban and Lead Poisoning Hazard.**

Surface paint on the wooden toys contains levels of lead that exceed the federal lead paint ban. Lead is toxic if ingested by young children and can cause adverse health effects. Consumers should immediately take the recalled toys away from children, and contact Stack Em’ Up Books to receive a prepaid shipping label to return the recalled product, regardless of whether they purchased the product or received it as a free giveaway. Consumers who purchased the product at [www.stackemupbooks.com](http://www.stackemupbooks.com) or the Philadelphia Gift Show will receive a full refund once they return the product. **Feb. 17, 2022: Lovevery Recalls Drinking Cup With Handle in The Inspector Play Kits Due to Choking Hazard.**

The handle can detach from the steel cup, posing a choking hazard to young children. These cups are part of Lovevery’s Inspector Play Kits. Consumers should immediately take the recalled drinking cups away from children, stop using them, and contact Lovevery for a free replacement cup. Consumers will receive a free replacement cup after writing “X Recalled X” inside the cup using a permanent marker, registering online, uploading a photo of their defaced cup, and affirming to Lovevery that the cup will be disposed of in the trash or recycled according to local guidelines. **March 17, 2022: HD Premier Recalls DigitDots Magnetic Balls Due to Ingestion Hazard.**

When two or more high-powered magnets are swallowed, either intentionally by younger children or accidentally by older children, the ingested magnets can attract to each other, or to another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death. Consumers should stop using the recalled magnets immediately, take them away from children, and contact HD Premier to receive a prepaid label to return the recalled products. Upon receipt of the products, HD Premier will provide consumers with a refund. **March 24, 2022: Boxine U.S. Recalls tonies Blocks Due to Magnet Ingestion Hazard; Sold Exclusively at tonies.com.**

When two or more high-powered magnets are swallowed, either intentionally by younger children or accidentally by older children, the ingested magnets can attract to each other, or to another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death. Consumers should stop using the recalled blocks immediately, take them away from children, and contact tonies for instructions on how to return the recalled blocks for a full refund. Consumers can also go to <https://tonies.happyreturns.com>, choose “Blocks Return” as the reason for the return, and tonies will then provide the customer with a return label. After the product has been received, tonies will provide the initial form of payment with a full refund and an additional \$14.99 tonies.com coupon code. tonies is also contacting all purchasers directly. 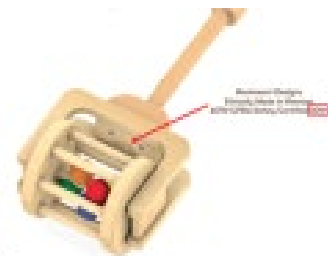

The toys’ yellow poles contain levels of lead that exceed the federal lead content ban. Lead is toxic if ingested by young children and can cause adverse health issues. Consumers should immediately stop using the recalled toys, and contact Jungle Jumperoo for information on how to properly dispose of the yellow poles and to receive free replacement poles. Tubes on the Activity Loops toys can detach from the base, releasing small plastic rings and posing a small parts choking hazard to children. The mirror can come out of the silicone bear cover if pushed, exposing the mirror’s sharp edges and posing a laceration hazard to children. Consumers should immediately take the toy away from children, stop using the recalled Konges Sløjld Baby Mirror Activity Toy, and contact Konges Sløjld for a full



refund. When attached to a crib, a protruding knob on the activity desks can become entangled with clothing on a child, posing an entanglement hazard.
