## **A message from Attorney General Kwame Raoul**

The holiday shopping season is well underway, and I am encouraging parents, grandparents, guardians and anyone who has children on their shopping list to review my office's annual Safe Shopping Guide to help avoid purchasing dangerous toys and children's products.

For more than 10 years, the Attorney General's office has issued an annual guide to help families learn about products that have been recalled over the past year so that they can avoid buying or can remove dangerous products from their homes. This year, the annual Safe Shopping Guide highlights 30 recalls issued by the U.S. Consumer Product Safety Commission during 2019. Descriptions of the toys, furniture, children's clothing and other children's products are accompanied by photographs to make hazardous products easier to identify.



This year, I am urging families to be aware of recalls of certain infant incline sleepers and infant rocking sleepers that have been connected to infant deaths. The guide also includes other recalled children's items, such as children's clothing that does not meet flammability standards, toys and clothing with small pieces that can break off and pose a choking hazard, knit toys that have been found to contain needles, and infant and children's furniture that, if not properly secured, can result in falls and other injuries. By reading the guide, families can ensure they do not have these recalled items in their homes, and can avoid purchasing them through yard sales or secondhand websites where they may still be available.

**August 20, 2019 recall announcement**  
**Crate and Barrel Recalls Push Walkers Due to Choking and Laceration Hazards**

Walkers can be damaged over time exposing sharp points and small parts, posing choking and laceration hazards to small children. Sold exclusively online at [ww.crateandbarrel.com](http://ww.crateandbarrel.com) from January through April 2019. Consumers should immediately stop using the recalled push walkers, put it out of reach of young children and contact Crate and Barrel for a full refund.

**August 29, 2019 recall announcement**  
**Pearhead Recalls Ubbi Connecting Bath Toys Due to Choking Hazard**

The recalled toys can break and create a sharp point, posing laceration and choking hazards to young children. Sold at buybuy BABY, Nordstrom, Bump Box and other specialty stores nationwide and online at Amazon.com and [ubbiworld.com](http://ubbiworld.com) from January 2019 through August 2019. Consumers should take the recalled Ubbi Connecting Bath Toys away from children and return them to Pearhead for a full refund and a free replacement Ubbi Squeeze Bath Toy.

Consumers should immediately stop using the knit dolls and contact The Beaufort Bonnet Company to receive a full refund in the form of a gift card.

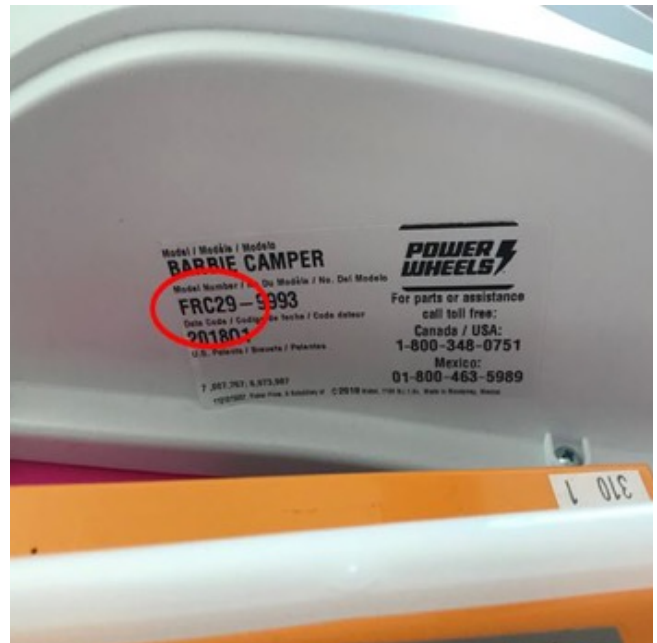

**February 5, 2019 recall announcement**  
**Fisher-Price Recalls Children's**  
**Power Wheels Barbie Campers**  
**Due to Injury Hazard**

The children's ride-on Power Wheels can continue to run after the foot pedal is released, posing an injury hazard. Sold exclusively at Walmart stores nationwide and on-line at Walmart.com from July 2018 through January 2019. Consumers should immediately take the recalled Power Wheels away from children, stop using them, and contact Fisher-Price for a free repair.

Consumers should immediately take the recalled toys away from children and return the toys to any Target store for a full refund.

**Flying Tiger Copenhagen Recalls Toy Train Carts Due to Choking Hazard**

The steam dome on the toy's train engine car can come loose, posing a choking hazard. Sold at Flying Tiger Copenhagen stores nationwide from November 2018 through March 2019. Consumers should take the recalled toy train cart away from children immediately and return it to the nearest Flying Tiger Copenhagen store for a full refund. No receipt is needed.

Consumers should immediately stop using the sock and rattle sets, take them away from children and return them to the store where it was purchased or contact London Bridge to receive a full refund.

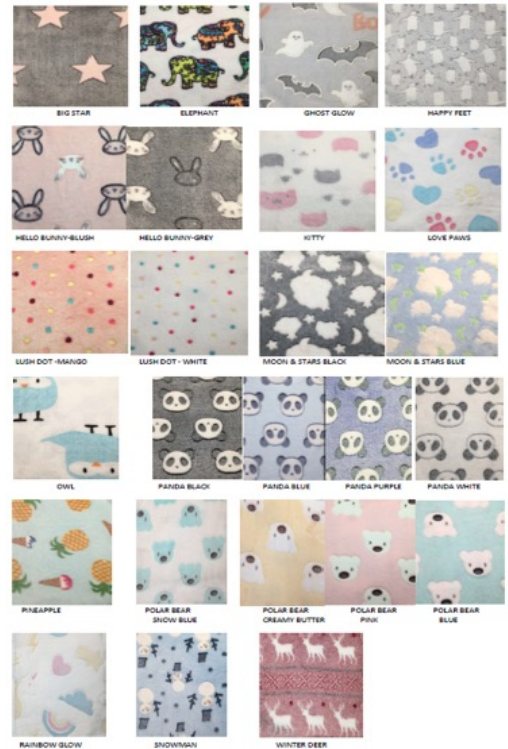

**March 14, 2019 recall announcement**

**Brush Art Recalls WIC Nutrition Plates Due to Fire Hazard**

The plates are incorrectly labeled as microwave-safe. They contain aluminum, which poses a fire hazard if microwaved. Distributed as a free promotional item exclusively by WIC clinics located in Indiana from August 2018 through November 2018. Consumers should immediately stop using the recalled plates and return them to their WIC Clinic for free replacement plates. Replacement plates are being manufactured and will be sent to Indiana WIC clinics when they become available.

Consumers should immediately stop using the product and contact Kids II for a refund or voucher.

Consumers should immediately stop using the recalled blankets and take them away from children. Consumers should contact Swaddle Bee to receive a full refund.

**The Boppy Company Recalls Infant Head and Neck Support Accessories Due to Suffocation Hazard**

The head support area can be overstuffed and cause the infant's head to be tilted too far forward, posing a suffocation hazard. Sold at Target, buybuy Baby and other juvenile products and discount furniture stores nationwide and online at Amazon.com from March 2019 through May 2019. Consumers should immediately stop using the head support and contact The Boppy Company for a full refund.

**Stokke Recalls Infant Steps Bouncers Due to Fall Hazard**

Consumers should immediately stop using the Stokke Steps Bouncer in combination with the Stokke Steps Chair and contact Stokke for a free repair kit.

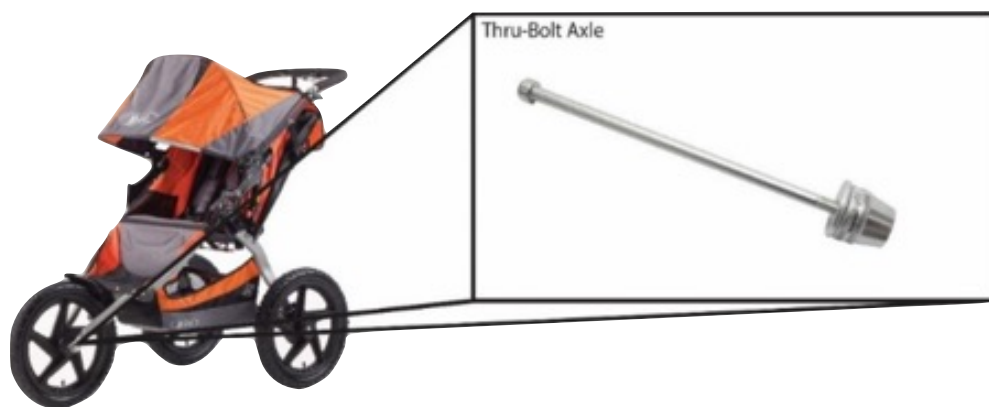
**July 25, 2019 recall announcement**

**Britax Recalls Modified Thru-Bolt Axles for Use with BOB Jogging Strollers Distributed Through the BOB Information Due to Fall and Injury Hazards**

The modified thru-bolt on the front wheel can fracture, allowing the wheel to detach from the stroller, posing fall and injury hazards to children in the stroller and adults operating the stroller. Distributed by Britax free of charge to consumers in connection with the BOB Information Campaign announced on January 10, 2019.

Consumers should immediately stop using the modified thru-bolt axle installed on the front wheel of their BOB jogging stroller. Britax is contacting consumers directly who received the modified thru-bolt axles and providing them with a free replacement thru-bolt axle. Those consumers may also contact Britax for a free replacement thru-bolt axle.

**Dorel Juvenile Group USA Recalls Inclined Sleepers Due to Safety Concerns About Inclined Sleep Products**

Infant fatalities have been reported while using other inclined sleep products, after the infants rolled from their back to their stomach or side while unrestrained, or under other circumstances. Sold at Target, Kmart, Ross, Marshalls, TJ Maxx and juvenile product stores nationwide from November 2014 through February 2017. Consumers should immediately stop using the inclined sleepers and contact Dorel for a refund in the form of a \$60 voucher.

**September 5, 2019 recall announcement**  
**Walker Edison Furniture Recalls Children's Bunk Beds Due to Fall and Injury Hazards**

The bunk bed's support boards can break, posing fall and injury hazards. Sold online at Overstock.com, Pier1.com, Target.com, WalkerEdison.com, Walmart.com, Wayfair.com and other online retailers from July 2018 through April 2019. Consumers should immediately stop using the bunk beds and contact Walker Edison Furniture to arrange for free replacement bunk beds and free installation by Walker Edison Furniture.

**October 3, 2019 recall announcement**  
**E&E Recalls Bedroom Dressers Due to Tip-Over and Entrapment Hazards**

The recalled dressers are unstable if they are not anchored to the wall, posing serious tip-over and entrapment hazards that can result in death or injuries to children. The dressers do not comply with the performance requirements of the U.S. voluntary industry standard (ASTM 2057-17). The dressers were sold online at bedbathandbeyond.com, jcpenny.com, kohls.com, macys.com, ollix.com, overstock.com and wayfair.com from January 2017 through September 2019.

Consumers should immediately stop using the recalled dressers unless properly anchored to the wall and place them in an area that children cannot access. Contact E&E for a full refund with free dresser pick-up or a free tip-over restraint kit and a one-time free in-home installation of the kit. Consumers can also choose to receive a pre-paid packaging label to ship their recalled dresser back to E&E for a full refund check or a \$400 Designer-living.com store credit.
