



# ILLINOIS SERVICE MEMBERS CIVIL RELIEF ACT

## What Is ISCRA?

When a service member enters active duty, many personal financial obligations may necessarily be disrupted. The Illinois Service Members Civil Relief Act or ISCRA provides protections from potential legal actions that could arise as he or she fulfills a military commitment.

## What Is The Purpose Of ISCRA?

ISCRA and the Federal Service Members Civil Relief Act or SCRA by definition: have the purpose to provide for, strengthen, and expedite the national defense through protections extended to service members of the United States to enable such persons to devote their entire energy to the defense needs of the nation and to provide for the temporary suspension of judicial and administrative proceedings and transactions that may adversely affect the civil rights of service members during their military service.

## What Protections Are Established Under ISCRA?

Protections under ISCRA include basic protections under the Service Members Civil Relief Act (SCRA). ISCRA expands on those protections for service members who are residents of the State of Illinois at the time that they enter into active duty service.

ISCRA protections include:

- The right to terminate certain contracts for services
- The right to terminate certain property and vehicle leases
- Protections from termination of cellular phone contracts
- Protections for bulk long-distance telephone services that are made available to immediate family members of service members who enter military service
- Limitations on interest rates on obligations entered into prior to entering active duty
- Protections against utility service stoppages and arrearage actions, evictions, foreclosures or judicial sales
- Protections against property repossessions under retail installment sales
- Protections against lapses in or forfeiture of life insurance policies
- Protections and relief from default judgments
- Stays of administrative case hearings
- Stays of prosecution in civil matters
- Certain protections related to school attendance and tuition refunds

## Who Is Protected Under ISCRA?

An individual must be a resident of Illinois who is a service member of any component of the U.S. Armed Forces or the National Guard of any state, the District of Columbia, a commonwealth, or a territory of the United States.

Protections occur for an individual who enters full-time training or duty, no matter how described under federal or state law when the service member is ordered to report by the President of the United States, governor of a state, commonwealth, or territory of the United States or other appropriate military authority.
