"THANKS, BUT NO THANKS"**

Attorney General Urges Group to Get Rid of Dangerous Cribs Rather than Market Them

Chicago — Attorney General Lisa Madigan today is denouncing the Juvenile Products Manufacturers Association's (JPMA) plans to launch its national "Safe Sleep" campaign in Chicago, saying it amounts to "peddling deadly merchandise in our own backyard where we fight daily to protect our children from such harmful products."

According to the Association's Web site, the group is embarking on a "five-city education and sleep product donation tour" beginning in Chicago on Wednesday in observation of annual Baby Safety Month.

"JPMA should take responsibility for certifying deadly drop-side cribs that have killed dozens of infants across the country. They should be launching an awareness campaign to ensure parents and caregivers know drop-side cribs have a deadly flaw, and people need to stop using them immediately," said Attorney General Madigan.

She also again demanded that JPMA remove its Certification Seal from dangerous drop-side cribs. The ASTM International, originally known as the American Society for Testing and Materials, strengthened its standard by banning drop-side cribs in December 2009. Yet JPMA refuses to force manufacturers to remove its seal from cribs that do not meet these new safety standards. The Attorney General's office staff has found drop-side cribs with the JPMA seal on retail sales floors as recently as July of this year.

"It's appalling that JPMA still allows drop-side cribs to carry the JPMA certification. At least 32 children have died in drop-side cribs, over 9 million of them have been recalled, and by the end of this year, the CPSC will ban the manufacture of cribs with this deadly design," said Madigan. "Yet JPMA still refuses to remove their seal from these deadly cribs."

Since 2007, over 9.5 million drop-side cribs have been recalled, with almost 4 million recalled in 2010 alone. The federal Consumer Product Safety Commission confirms that 32 infants have died in drop-side cribs. Beginning in December 2009, new nationwide industry standards banned drop-sides as a feature of cribs. Based on these standards, drop-side cribs are now deemed unsafe under Illinois law.

"JPMA wants you to believe that it is concerned for the safety of your infant when its actions prove otherwise. When confronted with the fact that cribs they certified have killed dozens of infants, JPMA blames the parents. It's clear that JPMA has one interest - selling their members' products regardless of their safety," Madigan said.

The Attorney General used the opportunity to remind parents and other caregivers that drop-side cribs – the very cribs that JPMA continues to promote – are deadly and should not be used. The Attorney General also has issued the "Rest Assured: Special Edition" consumer guide, which provides important information to consumers about every drop-side crib recall that has occurred since 2007, including information on the 12 recalls that have occurred in 2010.

The guide identifies which cribs were recalled by make and model, when and where the cribs were sold and what to do if you own one of these recalled cribs. IS YOUR BABY SLEEPING IN A DROP-SIDE CRIB?



A Message from Attorney General Lisa Madigan

As you prepare your home for a new baby, you will have many decisions to make. One of the biggest decisions you will face is the choice of a crib. All parents want to provide their children with a safe sleep environment. After all, this is the one place where you will leave your baby alone and unattended.

When you make this important decision, I urge you to be sure that your crib has not been recalled. I am concerned, in particular, about cribs that have a drop side. Since 2007, more than 9.5 million drop-side cribs have been recalled. In 2010 alone, there have been 12 recalls for drop-side cribs covering almost 4 million individual cribs. Even more disturbing are reports from the federal Consumer Product Safety Commission that indicate that 32 infants have died in drop-side cribs.

Beginning in December 2009, new nationwide industry standards banned drop sides as a feature of cribs. Based on these standards, drop-side cribs are now deemed unsafe under Illinois law. Additionally, the Consumer Product Safety Commission announced this summer that it is beginning work on mandatory federal standards that will outlaw drop-side cribs nationwide. Those standards should be completed by the end of the year.

If you are using a drop-side crib, I hope that you will consider the number of deaths and injuries associated with these products. If you have a safe place where your baby can sleep, such as a fixed-side crib or a play yard, I encourage you to use that instead.

I created this Guide to help parents, grandparents and caregivers determine if a drop-side crib has been recalled. I hope that you will take a moment to check your child's crib and make sure it is safe.

Finally, the Consumer Product Safety Commission provides an easy, convenient way to stay updated on recalls by signing up for e-mail notification of recalls at www.cpsc.gov. You can also check the list of recalls to determine if you have other dangerous products in your home.

How do I know if I have one of these cribs?

This recall involves all Pottery Barn Kids drop-side cribs regardless of the model number. The Pottery Barn Kids insignia is printed on a label attached to the crib headboard or footboard.

Why should I be worried?

The drop side of the crib can detach if the crib's hardware is defective. When the drop side detaches it creates a space in which an infant or toddler can become entrapped and suffocate or strangle. Additionally, when the drop-side hardware fails or disengages, an infant or toddler can be injured by falling out of the crib.

What should I do?

In addition, the wooden stabilizer bars on some Delta drop-side and fixed-side cribs can be installed upside down, which puts extra stress on the crib and can cause the mattress platform to collapse, creating a gap in which an infant or toddler can become entrapped and strangle or suffocate.

Generation 2 went out of business in 2005. It is believed that more than 500,000 of these cribs were sold to consumers. The known model numbers are listed below. The "X" indicates where an additional and varying number may appear at the end of the model number.

When the drop side detaches it creates a space in which an infant or toddler can become entrapped and suffocate or strangle. Additionally, when the drop-side hardware fails or disengages, an infant or toddler can be injured by falling out of the crib. **Three children died in this crib.**

What should I do?

Stop using the crib immediately. Contact the store where you purchased the crib. You might be entitled to a refund, replacement crib, or store credit.

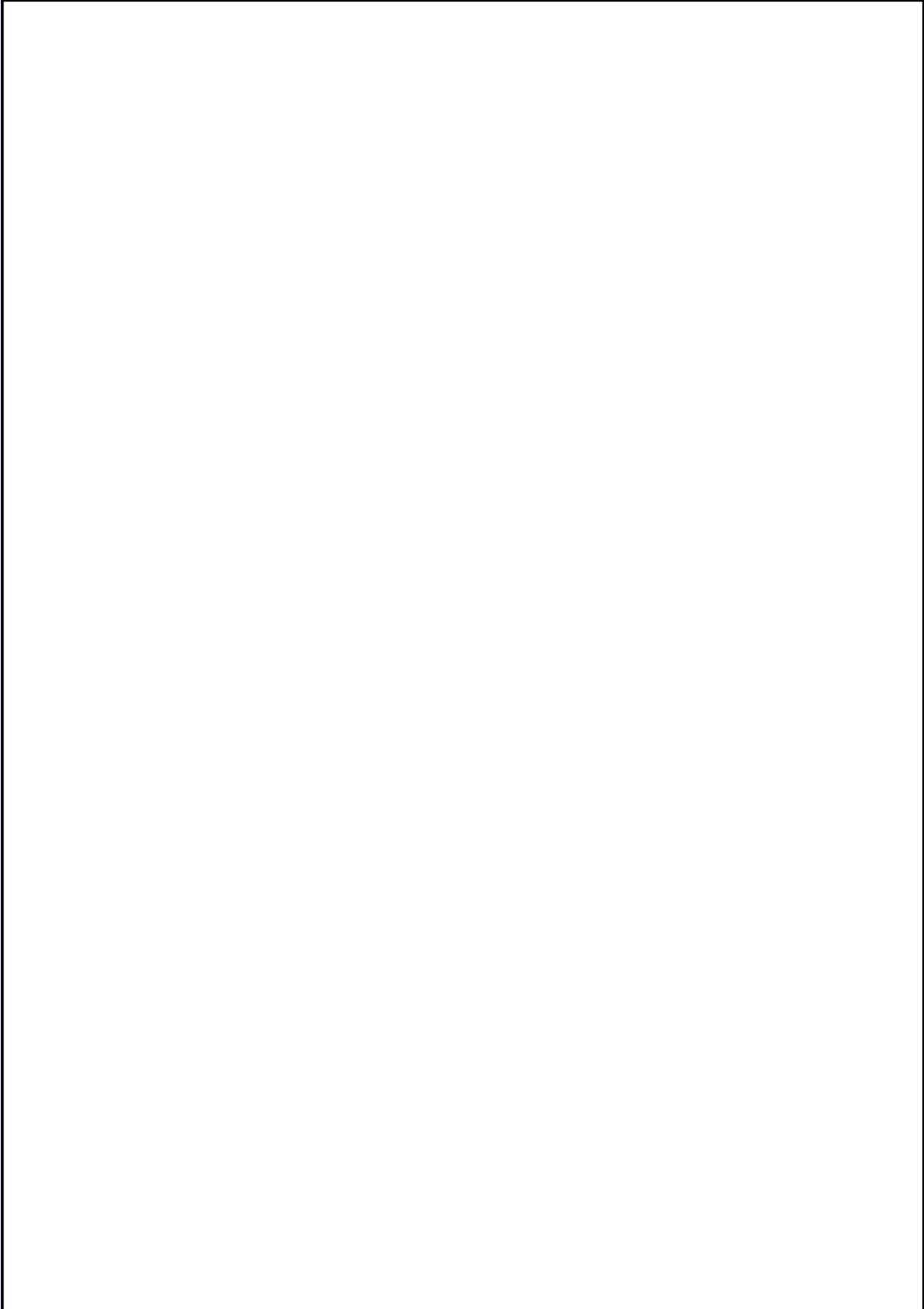

How do I know if I have one of these cribs?

The recall includes all Stork Craft drop-side cribs with a plastic trigger and one-hand system drop-side hardware. This recall does not involve any cribs with metal rod drop-side hardware. The recalled Stork Craft drop-side cribs may carry the Fisher-Price brand name.

The recalled cribs have a manufacturing date between January 1993 and October 2009. Stork Craft cribs with the Fisher-Price logo have manufacturing dates between October 1997 and December 2004. The date will be listed on a label located on the assembly instruction sheet attached to the mattress support board.

Why should I be worried?

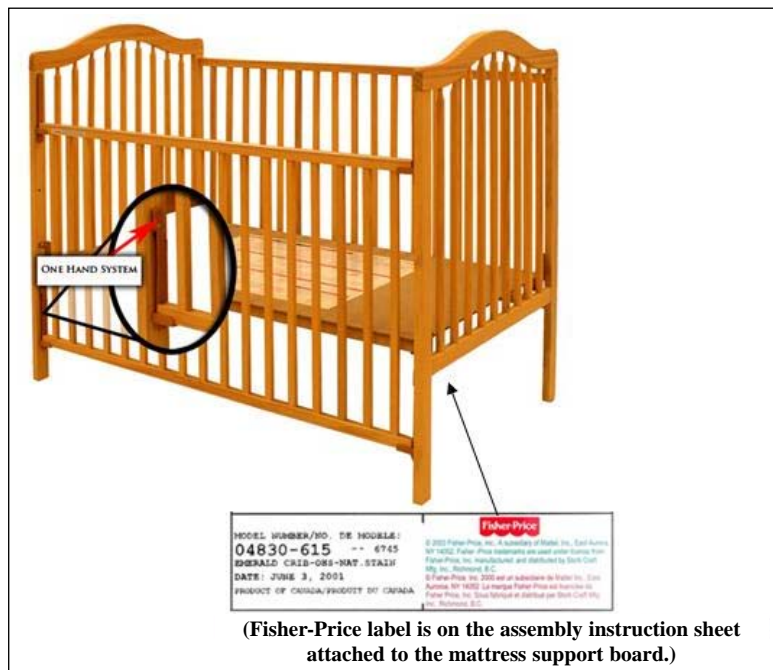

How do I know if I have one of these cribs?

All Babi Italia "Pinehurst" or Bonavita "Hudson" drop-side cribs with production dates from December 2006 through August 2007 are included in this recall. The production date is printed on a label attached to the footboard or headboard.

Why should I be worried?

The drop side of the crib can detach if the lower "spring pin" is defective. The pins are located on the footboard and headboard. A defective pin can cause the drop side to detach from the crib. When the drop side detaches it creates a space in which an infant or toddler can become entrapped and suffocate or strangle. Additionally, when the drop-side hardware fails or disengages, an infant or toddler can be injured by falling out of the crib.

What should I do?

Stop using the crib immediately. Call LaJobi at 1-800-266-2848 or visit www.lajobi.com to receive a free repair kit.

Where and when were they sold?

The Babi Italia "Pinehurst" cribs were sold exclusively by Babies "R" Us. Bonavita "Hudson" cribs were sold at Baby Basics, Beautiful Beginnings, and Buy Buy Baby stores and children's product stores nationwide for about \$300. The cribs were sold from December 2006 through December 2007.

When the drop side detaches it creates a space in which an infant or toddler can become entrapped and suffocate or strangle. Additionally, when the drop-side hardware fails or disengages, an infant or toddler can be injured by falling out of the crib.

One child died in this crib.

What should I do?

Where and when were they sold?

Additionally, when the drop-side hardware fails or disengages, an infant or toddler can be injured by falling out of the crib. **One child died in this crib.**

What should I do?

Where and when were they sold?

The cribs were sold at major retailers nationwide from January 2000 through January 2007 for between \$33 and \$200.

How do I know if I have one of these cribs?

ALL Simplicity drop-side cribs, including some that carry the Graco brand name and some that have a Winnie-the-Pooh motif, have been recalled. Simplicity has had four separate recalls for drop-side cribs in 2007, 2008 and 2009. The known model numbers are listed below and can be found on an envelope attached to the mattress support rails, or on a label attached to the interior side of the headboard.

Model Names include the Aspen 3 in 1, Aspen 4 in 1, Nursery-in-a-Box, Crib N Changer Combo, Chelsea, Pooh 4 in 1, Gabrielle, Camille, Providence, Shenandoah and Lancaster. Some Simplicity Cribs carry the Graco brand name including the Aspen 3 in 1, Ultra 3 in 1, Ultra 4 in 1, Ultra 5 in 1, Whitney and the Trio.

Why should I be worried?

Simplicity drop-side cribs are responsible for the deaths of 11 infants and toddlers. The drop-side hardware can fail causing the drop side to detach from the crib. When the drop side detaches it creates a space in which an infant or toddler can become entrapped and suffocate or strangle. Additionally, when the drop-side hardware fails or disengages, an infant or toddler can be injured by falling out of the crib.

Some Simplicity cribs have also been recalled because of mattress support defects. The screws on cribs with a **wooden mattress support** can come loose, allowing a portion of the mattress to fall, posing a suffocation hazard to young children.

Additionally, all Simplicity drop-side and fixed-side cribs with a **tubular metal mattress support** have been recalled. The crib's tubular metal mattress support frame can bend or detach and cause part of the mattress to collapse, creating a space into which an infant or toddler can roll and become wedged or entrapped. **A one-year-old child suffocated when he became entrapped between the crib mattress and the crib frame in April 2008.**

What should I do?

Stop using the crib immediately. For many of these cribs, consumers will not be able to return the crib for a refund or store credit. Simplicity is no longer in business. The repair kit to immobilize the drop side is also not available. Please do not try to fix the crib yourself.

Some retailers, including Wal-Mart and Target, have agreed to take back some models of Simplicity cribs. To determine if you have one of these cribs, check the following chart. If you are unable to afford a new crib or play yard for your child, please contact the Illinois Attorney General's Product Recall Hotline at 1-888-414-7678 for assistance.

Where and when were they sold?

The cribs were sold at department stores, children's product stores, and mass merchandisers nationwide. Retailers include Wal-Mart, Target, Babies "R" Us, Burlington Coat Factory, Shopko, Meijer, AAFES, K's Merchandise and Nebraska Furniture Mart from January 1998 through June 2009 for between \$100 and \$300.

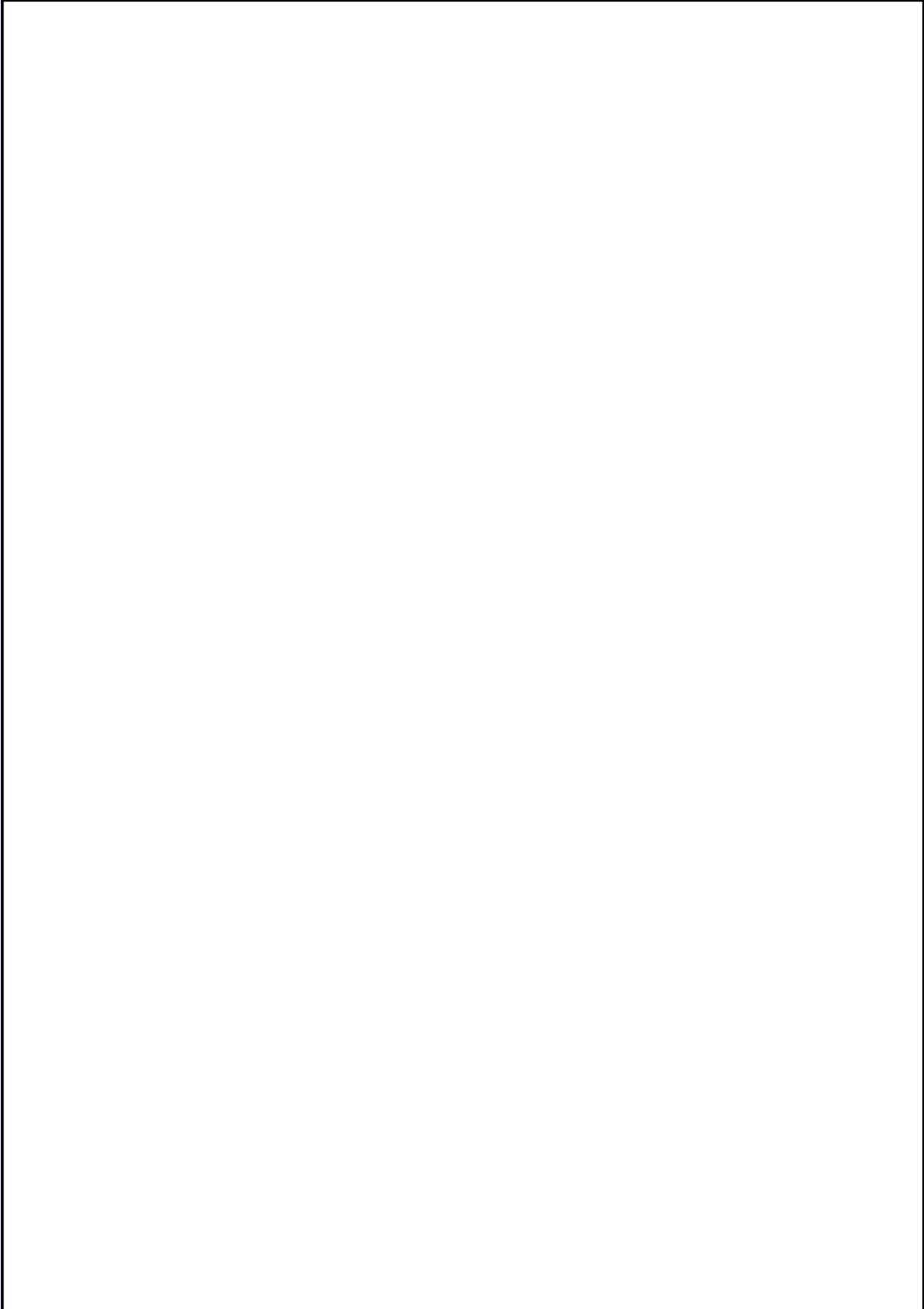

SAFE SLEEP TIPS

Provided by Kids in Danger

A nonprofit organization dedicated to protecting children by improving children's product safety

A crib is the most important safety equipment parents buy for their new baby. **Safety is the primary role of the crib** or other sleep environment. Kids in Danger recommends that caregivers review the following safe sleep tips before buying and using a crib.

When choosing a crib, you should know that:

- A crib made before 1999 will not meet current safety standards.
- Even a newer used crib might have missing hardware or loose parts, or be subject to a recall. If you are using a crib that has been used before – by you, by a friend or that you bought secondhand – check it carefully against the recall list at www.cpsc.gov and only use it if you have the instructions, all the parts, and the components fit together snugly.
- Kids in Danger does not recommend using a secondhand drop-side crib.

Check ALL cribs for:

- Slats that are too far apart and might entrap a child (if a soda can fits between the slats, the gap is too wide);
- Corner post extensions that can catch on a child's clothing or toys;
- Hardware, such as screws and bolts, that are loose, missing or protruding (be sure to check the mattress support hangers to ensure they are secure);
- A mattress that is too loose (you should not be able to fit two fingers between the mattress and crib's side);
- Joints and parts that do not fit tightly together;
- Cracked or peeling paint, and wood that is not smooth or has splinters; and
- Drop-side rails that do not lock properly and securely when in the raised position.

The best sleep environment is a safe crib with a tight-fitting mattress and sheet, and nothing inside except your baby. When using a crib:

- Read and follow carefully the directions for assembly and use. Replacement instructions can be obtained from the manufacturer;
- Remove soft bedding such as pillows, blankets, sleep positioners, bumper pads, and stuffed toys;
- Use sheets that are tight-fitting;
- Position mobiles out of child's reach and remove them when the child starts to push up;
- Never hang anything on or above the crib with ribbon or string;
- Drop the mattress to the lowest position when a child can pull themselves up;
- Clothe your baby lightly for sleep. Avoid over-bundling. Use a blanket sleeper (or sleep sack) if needed to keep blankets and other coverings out of the crib.
