

2007 Safe Shopping Guide Children's Product Recalls



A Message from Illinois Attorney General Lisa Madigan

With the holidays fast approaching, many Illinoisans will soon be busy gift shopping for friends and family. This year, however, parents and others shopping for children may find themselves in toy stores wondering what is safe and what is not.

In 2007, there have been widespread recalls of children's products. Since January, hundreds of different toys and children's jewelry pieces - amounting to more than 44 million individual units - were recalled. In addition, more than thirty juvenile durable products, including items such as cribs and car seats, and numerous clothing products were recalled.

Recalls may be issued for a variety of reasons, ranging from small parts that can detach and pose a choking hazard, to toys that are coated in lead-based paint. Whatever the cause of the recall, it is vital that dangerous products are removed from children immediately.

Because children are particularly vulnerable to dangerous consumer products, people purchasing gifts for kids are right to be concerned about safety. The ideal situation is to prevent dangerous products from ever reaching our kids in the first place. For this reason, my office, pursuant to the Children's Product Safety Act, requires that Illinois retailers remove dangerous products from store shelves and post recall notices in prominent locations. While these measures help keep dangerous products out of consumers' hands, they are not infallible.

In order to help consumers shop with confidence and to ensure that dangerous products are kept away from children, my office developed this Safe Shopping Guide, which provides a photograph and short description of each and every children's product recalled in 2007. The Safe Shopping Guide is separated into five parts for easy reference: toys, children's jewelry, juvenile durable products, children's clothing, and ATVs and bicycles.

It is my hope that you will carry this Guide with you as you shop and consult it before making your purchases. You can also use it to check the presents your kids receive from friends and family. By taking this simple precaution, you can help to ensure the safety of your children's gifts.

I wish you and your family a joyous-and safe-holiday season.

Children's Product Recalls



Toys

The following is a list of toy recalls issued between January 1, 2007 and December 31, 2007.



Bright Starts Teethers Recalled on January 17, 2007

The flexible plastic ring that holds the teether beads in place can crack or break allowing the beads to detach, posing a choking hazard to infants. The teethers were sold at discount department stores and juvenile specialty stores nationwide from June 2006 to January 2007.



Baby Rattles and Ornaments Recalled on January 18, 2007

The small parts on the plush rattles and the frame ornaments can break or detach, posing a choking hazard to young children. Additionally, the rattles' plastic ring can break and expose sharp points. The rattles and ornaments were sold at Target stores from November 2006 to December 2006.



MagneBlocks Toys Recalled on January 18, 2007

Tiny, powerful magnets inside the building pieces can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at discount department stores, toy stores and arts and crafts stores nationwide from January 2004 to November 2006.



Easy Bake Ovens Recalled on February 6, 2007, with an expanded recall issued on July 19, 2007

Young children can insert their hands into the oven's opening and get their hands or fingers caught in the oven's opening, which can result in serious burns. At least one child had her finger partially amputated. The toy was sold at Toys R Us, Wal-Mart, Target, KB Toys and other retailers nationwide from May 2006 to February 2007.



JAKKS Pacific Toy Vehicles Recalled on February 13, 2007

The batteries in the toy vehicles can ignite while charging, posing a fire hazard. The toys were sold at toy stores, discount department stores and internet retailers nationwide from August 2006 to January 2007.



Fisher Price "Laugh and Learn" Bunny Toys Recalled on February 15, 2007

The pink pompom nose can detach and pose a choking hazard for young children. The toy was sold at discount department stores and toy stores nationwide from May 2006 to December 2006.




Link-N-Lite Magnetic Light-Up Puzzles Recalled on February 15, 2007

Tiny, powerful magnets inside the puzzle pieces can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at Target and Kohl's stores nationwide and on Amazon.com from June 2006 to January 2007.



Sportcraft Inflatable Bounce Houses Recalled on February 27, 2007

The fan and the plastic housing surrounding the fan can break apart during use of the inflatable bounce house, posing a risk of impact injury to consumers. The items were sold at Academy Sports and Outdoor and Sport Chalet nationwide from September 2006 to January 2007.



Two-Sided Easels Recalled on March 7, 2007

The paint on the chalkboard side of the easels contains high levels of lead. The easels were sold through Discount School Supply catalogues and website from July 2004 to November 2006.



Children's Stationary Set Recalled on March 13, 2007

The stationary set contains a razor blade cutter with a sharp edge, posing a laceration hazard to young children. The sets were sold at Dollar Stores in northern California from January 2005 to March 2007.



"Elite Operations" Toy Sets Recalled on March 13, 2007

The toys contain high levels of lead, and have sharp points that pose a laceration hazard. The toy sets were sold at Toys R Us nationwide from January 2006 to February 2007.



Estes-Cox Radio Control Airplanes Recalled on March 27, 2007

The airplanes can overheat while recharging, posing a fire hazard. The Sky Squadron Airplane was sold at Radio Shack nationwide from December 2006 to February 2007. The Sky Ranger Airplane was sold at Wal-Mart nation-wide from January 2007 to February 2007.



Stuffed Ball Toys Recalled on March 28, 2007

The paint on the toys contains high levels of lead. The toys were sold at Dollar Stores nationwide from June 2006 to March 2007.



Baby Dolls Recalled on April 4, 2007

The "Lovely Baby" and "Happy Baby" dolls contain small parts, which can detach and pose a choking hazard to young children. The dolls were sold at Dollar Stores nationwide from September 2006 to October 2006.




Activity Carts Toys Recalled on April 4, 2007

The orange hubcaps on the wheels of the Little Tree Wood Activity Carts can detach and pose a choking hazard to young children. The toys were sold at Target stores nationwide from July 2006 to March 2007, and on Target.com from October 2006 to February 2007.



Disney Plush Easter Baskets Recalled on April 5, 2007

The silver beads and ribbons attached to the basket can detach and pose a choking hazard. The baskets were sold at Wal-Mart nationwide from February 2007 to March 2007.



Small World Puzzles Recalled on April 11, 2007

The knobs on the puzzles can come off and pose a choking hazard. The "Sounds on the Farm" and "Sounds on the Go" puzzles were sold under the Puzzibilities and Ryan's Room brands. Puzzibilities puzzles were sold at toy stores and various retailers nationwide from June 2003 to February 2007. Ryan's Room puzzles were sold at Target stores nationwide from January 2006 to February 2007.



Shrek Headbands Recalled on April 17, 2007

A small wire can protrude through the fabric of the ears on the headbands, and can cause cuts. The headbands were distributed as a giveaway to Pepsi employees from February 23, 2007 to April 1, 2007.



Magnetix Magnetic Building Sets Recalled on March 31, 2006 with an expanded recall issued on April 19, 2007

Tiny, powerful magnets inside the building sets can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at mass merchants and other toy and arts and crafts stores nationwide from September 2003 through March 2006.



Anima Bamboo Collection Games Recalled on May 2, 2007

The toys in the game sets are covered in paint that contains high levels of lead. The games were sold at Target stores nationwide from December 2006 to April 2007.



Soft Blocks Tower Toys on Graco Baby Einstein Discover and Play Activity Centers Recalled on May 2, 2007

The plastic covering on the soft block towers can detach and pose a choking hazard to infants. The toys were sold at Army and Air Force Exchange Services, Babies R Us, Toys R Us, Meijer, Shopko, Target and various other retailers nationwide, and on Wal-Mart.com and Target.com from February 2005 to December 2005.



Parents Magazine Record-A-Voice Toy Cell Phones Recalled on May 3, 2007

The metal pin inside the hinge of the cell phone flip-top can fall out, posing a choking hazard to young children. The toys were sold at Target stores nationwide from September 2006 to January 2007.



IQ Preschool Take Apart Townhouses Recalled on May 3, 2007

Tiny, powerful magnets used to connect the wooden pieces to the sides of the townhouse can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at various toy stores and other retailers from December 2004 to February 2007.



Baby Buddy Clip-On Books Recalled on May 17, 2007

The metal clip used to attach the book to a stroller or article of clothing can break, posing a choking hazard to children. The item was sold through Bookspan mail order catalogues, and Bookspan.com from September 2006 to March 2007.




Discovery Bunny Books Recalled on May 17, 2007

The seam on the bunny's left hind leg can open exposing a plastic squeaker toy contained inside a cloth bag, posing a choking hazard to young children. The item was sold through Bookspan mail order catalogues, and Bookspan.com from February 2006 to March 2007.



Ball Rattles, Wrist Rattles and Wind-up Toys Recalled on May 23, 2007

The toys contain small parts that pose a choking hazard to young children. The toys were sold at Dollar Stores in California from January 2005 through May 2007.



"Soldier Bear" Toy Sets Recalled on May 23, 2007

The toy action figures are covered in paint that contains high amounts of lead. The sets were sold at Army and Air Force Exchange Services from August 2006 to April 2007.



Toy Drums Recalled on May 30, 2007

The red paint on the drums contains high amounts of lead. The toys were sold at gift and collectible stores nationwide from June 2005 to April 2007.



Flashing Eyeball Toys Recalled on June 7, 2007

The plastic eyeball contains kerosene, which if broken, presents a chemical hazard to children. The toys were sold at toy and novelty stores during July 2006.



Wooden Thomas and Friends Toys Recalled on June 13, 2007

The surface paint on the wooden toys contains high amounts of lead. The toys were sold at toy stores and various retailers nationwide from January 2005 to June 2007.



Toy Barbeque Grills Recalled on June 28, 2007

The circular ashtray attached to the stainless steel legs of the grill could contain sharp edges, posing a laceration hazard. The toy was sold at Target stores nationwide from December 2006 to February 2007.



Shape Sorting Toy Castles Recalled on July 3, 2007

The plastic rod can come loose allowing the colored counting beads to slide off of the toy, posing a choking hazard to young children. The toy was sold at Wal-Mart, Target, Marshalls, Meijers and other specialty toy retailers nationwide from January 2006 to May 2007.



Mag Stix Magnetic Building Sets Recalled on July 5, 2007

Tiny, powerful magnets inside the plastic sticks can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at Kipp Brothers' showroom, Fall 2005 catalog and website from September 2005 to March 2006.



Remote Control Airplanes Recalled on July 24, 2007

The airplanes are launched by hand and can explode near the consumer's head, posing a risk of temporary hearing loss and injuries to eyes, face and hands. The airplanes were sold at hobby stores and other retailers nationwide from September 2005 to December 2006.



"Soldier Bear" Toy Sets Recalled on July 18, 2007

Surface paints on the toy action figures, dinosaurs and animals contain high amounts of lead. The sets were sold at Army and Air Force Exchange Services from August 2005 to April 2007.







"Soldier Bear" Toy Sets Recalled on July 18, 2007

Surface paints on the toy action figures, dinosaurs and animals contain high amounts of lead. The sets were sold at Army and Air Force Exchange Services from August 2005 to April 2007.



Magnetic Toy Train Sets Recalled on August 21, 2007

The paint on the trains contains high amounts of lead. The trains were sold at Johnson Smith Company, The Paragon Gifts, Inc., and Starcrest Products of California catalogues nationwide from December 2006 to July 2007.



Pacifiers Decorated with Crystals Recalled on July 26, 2007

These pacifiers fail to meet federal safety standards for pacifiers. The crystals can separate easily, posing an aspiration and ingestion hazard to young children. The pacifiers were sold online at ebay.com and etsy.com in 2006 and 2007.



Sarge Toys Recalled on August 14, 2007

Surface paints on the toys contain high amounts of lead. The toy was sold at retail stores from May 2007 to August 2007.



Fisher Price Toys Recalled on August 2, 2007

The surface paints on the toys, which include toys based on characters such as Sesame Street, Dora the Explorer and Elmo, contain high amounts of lead. The toys were sold at retail stores nationwide from May 2007 to August 2007.

Toys Sold with Sleeping Bags Recalled on August 3, 2007

The plastic button eyes on the stuffed horse and the pompom nose on the fairy doll can easily detach, posing a choking hazard to young children. The toys were sold in the Orvis Company mail order catalogue and the firm's website from September 2006 to December 2006.











Batman and One Piece Magnetic Action Figures Sets Recalled on August 14, 2007

Tiny, powerful magnets inside the accessories of the toy figures can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at discount department stores and toy stores nationwide from June 2006 to June 2007.



Barbie and Tanner Magnetic Toys Recalled on August 14, 2007

Tiny, powerful magnets inside the "scooper" accessory can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toys were sold at toy stores and various retailers nationwide from May 2006 to August 2007.





Doggie Day Care Magnetic Toys Recalled on August 14, 2007

Tiny, powerful magnets inside the toys can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toys were sold at toy stores and various retailers nationwide from July 2004 to August 2007.



Polly Pocket Play Sets Recalled on November 21, 2006 and expanded on August 14, 2007

Tiny, powerful magnets inside the dolls and accessories can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at toy stores and various retailers from May 2003 to November 2006.


Polly Pocket Play Sets Recalled on November 21, 2006 and expanded on August 14, 2007

Tiny, powerful magnets inside the dolls and accessories can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at toy stores and various retailers from May 2003 to November 2006.




Thomas and Friends, Curious George and Other Spinning Tops and Tin Pails Recalled on August 22, 2007

The paint on the wooden handles of the tops and the pails contain high amounts of lead. The toys were sold at specialty toy stores and gift shops nationwide from July 2001 to September 2002.



SpongeBob Squarepants Address Books and Journals Recalled on August 22, 2007

The paint on the metal spiral bindings of the address book and journals contains high amounts of lead. The books and journals were sold at retail stores nationwide from June 2006 to July 2007.



Teether Books Recalled on August 23, 2007

Small pieces of the teether can break off, posing a choking hazard to young children. The books were sold at Barnes and Noble and other bookstores and retailers from January 2006 to June 2007.



Children's Watering Cans Recalled on August 28, 2007

The beak of the watering can contains high amounts of lead. The toy was sold at Jo-Ann Fabric and Craft Stores nationwide from February 2007 to August 2007.



Wooden Coloring Cases Recalled on August 30, 2007

The printed ink on the outer packaging of the wood case contains high amounts of lead. The cases were sold at Toys R Us nationwide from October 2006 to August 2007.















Barbie Accessory Toys Recalled on September 4, 2007

Surface paint on the toys contains high amounts of lead. The toys were sold at retail stores nationwide from October 2006 to August 2007.



Geo Trax Locomotive Toys Recalled on September 4, 2007

The surface paint on the toys contains high amounts of lead. The toys were sold at retail stores nationwide from September 2006 to August 2007.



Bongo Band Toys Recalled on September 4, 2007

Surface paint on the toys contains high amounts of lead. The toys were sold at retail stores nationwide from July 2007 to August 2007.



Thomas and Friends Wooden Toys Recalled on September 26, 2007

Surface paint on the toys contains high amounts of lead. The toys were sold at toy stores and various retailers nationwide from March 2003 to September 2007.



Toy Gardening Tools and Children's Chairs Recalled on September 26, 2007

The surface paint on the Happy Giddy Gardening Tools and the Children's Sunny Patch Chairs contains high levels of lead. Both items were sold at Target stores nationwide from August 2006 to August 2007.



Knights of the Sword Toys Recalled on September 26, 2007

Surface paint on the toy knights contains high amounts of lead. The toys were sold at specialty toy stores nationwide from April 2004 to March 2006.



Toy Rakes Recalled on September 26, 2007

Surface paint on the handle of the rakes contains high amounts of lead. The rakes were sold at Jo-Ann Fabric and Craft stores nationwide from January 2007 to September 2007.



Children's Puppet Theaters Recalled on September 26, 2007

Surface paint on the puppet theater's wooden panels contains high levels of lead. The items were sold at specialty toy stores, gift shops, catalogs and websites nationwide from June 2006 to August 2007.



Doll Strollers Recalled on September 28, 2007

A child's finger can become caught in the rectangular metal clip or the black plastic side hinge, and this can sever a child's finger tip. Also, the strollers pose an entrapment hazard. The toy was sold at Pottery Barn Kids stores nationwide from October 2005 to June 2007.



Model Rockets Recalled on September 28, 2007

The model rocket's side or engine retainer ring can separate and cause the rocket to fall without the nose cone separating and the parachute deploying, posing a risk of an impact injury to nearby individuals. The rockets were sold at hobby stores and other retailers nationwide from June 2005 to July 2007.



Plush Boys Rattles Recalled on October 2, 2007

The rattles can break open releasing small beads inside, posing a choking hazard to young children. The rattles were sold at Target stores nationwide from March 2007 to May 2007.



Wooden Toys Recalled on October 4, 2007

The surface paint on the toys contains high amounts of lead. All toys were sold at KB Toy Stores nationwide. The Pull-Along Wagons were sold from August 2005 to August 2007. The 10-in-1 Activity Learning Carts were sold from August 2006 to September 2007. The Flip-Flop Alphabet Blocks were sold from August 2006 to September 2007.



Baby Einstein Discover & Play Color Blocks Recalled on October 4, 2007

Surface paint on the blue block contains high amounts of lead. The blocks were sold at various retailers and specialty stores nationwide from June 2007 to September 2007.



"Pirates of the Caribbean" Squeeze Flashlights Recalled on October 4, 2007

Surface paint on the leather strap attached to the medallion squeeze light contains high amounts of lead. The flashlights were sold at various retail stores and websites nationwide from September 2006 to October 2007.



Children's Decorating Sets Recalled on October 4, 2007

Surface paint on the back of the mirror contains high amounts of lead. The sets were sold at Toys R Us nationwide from May 2007 to September 2007.



Kidnastics Balance Beams Recalled on October 11, 2007

Surface paint on the balance beam contains high amounts of lead. The balance beams were sold in various catalogs and websites from January 2007 to September 2007.





Bendable Dinosaur Toys Recalled on October 11, 2007

The toys contain high amounts of lead. They were sold at the Kipps Brothers' Showroom, catalog and website from October 2006 to August 2007.



Travel Art Sets Recalled on October 11, 2007

The surface paint on the zipper pull of the lap desk contains high amounts of lead. The sets were sold at Cracker Barrel Old Country Stores nationwide from April 2007 to August 2007.



Winnie the Pooh Play Sets Recalled on October 11, 2007

Surface paint on the play sets contains high amounts of lead. The sets were sold through the J.C. Penney catalog, website and outlet stores nationwide from August 2005 to August 2007.



Breyer Stirrup Ornaments Recalled on October 11, 2007

Surface paint on the ornaments contains high amounts of lead. The ornaments were sold through the J.C. Penney catalog and website from August 2006 to August 2007.



Deluxe Art Sets Recalled on October 11, 2007

Surface paint on the outside of the wooden box contains high amounts of lead. The sets were sold through the J.C. Penney catalog and website from September 2005 to August 2007.



Dunkin' Donuts Glow Sticks Recalled on October 17, 2007

The glow sticks are not properly labeled to warn consumers that the cap and lanyard can detach, posing a choking hazard to young children. Additionally, the lanyard poses a strangulation hazard. The glow sticks were given away at Dunkin' Donuts with a purchase of donuts from September 2007 to October 2007.



Children's Puppet Theaters Recalled on October 17, 2007

Surface paint on the theater's wooden panels contains high amounts of lead. The theaters were sold in specialty toy stores, gift shops, catalogs and websites nationwide from June 2006 to August 2007.



Halloween Skull Pails Recalled on October 17, 2007

The surface paint on the eyes, nose and teeth of the skull contains high amounts of lead. The pails were sold at retail stores nationwide from September 2007 to October 2007.



Toy Swords Recalled on October 18, 2007

The swords can break, creating a sharp point, which poses a laceration hazard to consumers. The swords were sold at Gymboree stores nationwide from August 2007 to September 2007.



Game Pieces Sold with "Cars" Backpacks Recalled on October 23, 2007

Tiny, powerful magnets inside the four game pieces can fall out. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at Target stores nationwide from February 2007 to September 2007.



"Go Diego Go" Boat Toys Recalled on October 25, 2007

Surface paint on the toys contains high amounts of lead. The toys were sold at retail stores nationwide from June 2007 to October 2007.



Children's Toy Garden Tools Recalled on October 25, 2007

Surface paint on the handle of the toy gardening tools contains high amounts of lead. The tools were sold at Jo-Ann Fabric and Craft stores nationwide from January 2007 to September 2007.



Halloween Pails Recalled on October 25, 2007

The green paint on the pails contains high amounts of lead. The pails were sold at Family Dollar Stores nationwide from August 2007 to October 2007.



Ribbit Board Games Recalled on October 31, 2007

Surface paint on the five frog-shaped wooden pieces contains high amounts of lead. The games were sold by SimplyFun independent consultants nationwide from March 2007 to October 2007.



Halloween "Ugly Teeth" Recalled on October 31, 2007

The surface paint on the teeth contains high amounts of lead. The teeth were sold at various retailers nationwide from January 2006 to October 2007.



Elite Operations Toys Recalled on October 31, 2007

Surface coatings on the toys contain high amounts of lead. The toys were sold at Toys R Us stores nationwide from July 2007 to October 2007.



Galaxy Warriors Toy Figures Recalled on October 31, 2007

Surface paint on the toys contains high amounts of lead. The toys were sold at Family Dollar Stores nationwide from January 2006 to October 2007.



Pearl-like Attachment Sold with Girl's Gift Sets Recalled on November 1, 2007

The surface coating on a plastic bead decorative packaging attachment contains high amounts of lead. The sets were sold at Limited Too stores, and in the catalog and website, nationwide from April 2007 to September 2007.



Laugh and Learn Kitchen Toys Recalled on November 6, 2007

Pieces of the faucet or the clock hands can detach, posing a choking hazard to young children. The toys were sold at various retail and specialty stores nationwide from May 2007 to October 2007.



"Skippy" Pool Toys Recalled on November 6, 2007.

The elastic tongue of the fish can break and forcefully come out and cut the users' hands during launching of the toy. The toys were sold at mass merchandisers and independent pool supply stores nationwide from February 2007 to September 2007.

Surface paint on the wheels and engine of the toys contains high amounts of lead. The toys were sold at National Hot Rod Association events through Schumacher Racing, and Matco Tools through door to door sales by its representatives from March 2007 to September 2007.



Toy Cars Recalled on November 7, 2007

Surface paint on the cars contains high amounts of lead. The cars were sold at Dollar General stores nationwide from April 2007 to October 2007.



Duck Family Collectable Toys Recalled on November 7, 2007

Surface paint on the ducks contains high amounts of lead. The toys were sold at specialty toy stores and gift shops nationwide from January 2007 to August 2007.



Spinning Tops Recalled on November 7, 2007

Surface paint on the wooden handle of the top contains high amounts of lead. The toys were sold at specialty toy stores and gift shops nationwide from April 2003 to November 2003.



Dizzy Ducks Music Box Recalled on November 7, 2007

The surface paint on the wooden base of the music box contains high amounts of lead. The music boxes were sold at specialty toy stores and gift shops nationwide from March 2007 to October 2007.



Toy Robot Recalled on November 7, 2007

Surface paint on the robot contains high amounts of lead. The toys were sold at specialty toy stores and gift shops nationwide from October 2006 to September 2007.



Aqua Dots Recalled on November 7, 2007

The coating on the beads that causes the beads to stick to each other when water is added contains a chemical that can turn toxic when many are ingested. Children who swallow the beads can become comatose, develop respiratory depression or have seizures. Aqua Dots were sold at mass merchandisers nationwide from April 2007 to November 2007.



Curious George Plush Dolls Recalled on November 8, 2007

Surface paint on the toy's plastic face and construction hat contains high amounts of lead. The dolls were sold at toy and discount department stores nationwide from December 2005 to August 2007.



Children's Sunglasses Recalled on November 8, 2007

The yellow surface paint on the sunglasses contains high amounts of lead. The sunglasses were sold at Dollar General stores nationwide from March 2005 to October 2007.



Halloween Themed Baskets Recalled on November 16, 2007

Surface paint on the bat, pumpkin, and witch emblems attached to the baskets contain high amounts of lead. The baskets were sold at Hobby Lobby stores nationwide from August 2007 to November 2007.



Snow and Sand Castle Kits Recalled on November 21, 2007

The Snow and Sand Castle Kits have a large plastic castle block maker in the kit that can crack at the handle during use, creating sharp edges that pose a laceration hazard to young children. 

Super Magnets toy Recalled on December 21, 2007

The magnet attached to the bottom of the small toy panda can detach. If more than one is swallowed, they can attract to each other and cause intestinal perforation or blockage, which can be fatal if not treated immediately. The toy was sold at dollar and gift stores nationwide from September 2005 to November 2007.



Tot Tower toy blocks Recalled on December 27, 2007

The plastic covering on the toy blocks can detach, posing a choking hazard to children. The toy was sold at specialty and gift shops nationwide from January 2003 to September 2007.





The highchair was sold at Babies R Us, Toys R US, Target, Wal-Mart, Burlington Coat Factory, Shopko, Army and Air Force Exchange Services, USA Baby and various specialty retailers nationwide from December 2005 to December 2006.



Next Step Plastic Sippy and Tumbler Cups Recalled on January 22, 2007

The impact of being dropped or banged can cause the cup to break into pieces, resulting in sharp or jagged edges that pose a laceration hazard to children. The cups were distributed by Mead Johnson Nutritionals as a promotional giveaway to physicians and consumers nationwide via direct mail from September 2006 to October 2006.



Infantino SlingRider Infant Carriers Recalled on March 22, 2007

The plastic slider on the fabric strap can break, causing the strap supporting the carrier to release and infants to fall out of the carrier. The carrier was sold at Target, Babies R Us, BJ's Wholesale Club, Burlington Coat Factory and other retailers nationwide from July 2006 to February 2007.



Baby Trend Back Pack Carriers Recalled on March 27, 2007

The stitching on the strap of the carrier can loosen or detach, causing the carrier to shift, posing a fall hazard to young children. The carrier was sold at discount department and juvenile products stores nationwide from March 2002 to November 2006.



Infant Bouncer Seats Recalled on April 18, 2007

The tubular metal frame can break, posing a fall hazard to infants in the seat. The seats were sold at juvenile specialty stores and web retailers nationwide from September 2006 to March 2007.



Evenflo Embrace Infant Car Seat and Carrier Recalled on May 10, 2007

When used as an infant carrier, the handle can unexpectedly release, causing the seat to rotate forward. When this happens, an infant inside the carrier can fall to the ground and suffer serious injuries. The product was sold at department and juvenile products stores nationwide from December 2004 to September 2006.



Fisher Price Rainforest Infant Swings Recalled on May 30, 2007

Infants can shift to one side of the swing and become caught between the frame and the seat, posing an entrapment hazard. The swings were sold at discount department stores and toy stores nationwide from November 2006 to May 2007.



Song Lin Sleigh Round Cribs Recalled on May 31, 2007

The assembly instructions for this crib direct consumers to assemble the crib with the mattress support in the highest position and do not indicate that the mattress support can be moved to a lower position. This poses a fall hazard to children who are able to sit or stand up in the crib. The cribs were sold at children's furniture stores nationwide from January 2005 to March 2007.



Simplicity Nursery-in-a-Box Recalled on June 6, 2007

The assembly instructions provided with the cribs incorrectly instructs consumers on how to attach the crib's drop side. If improperly installed, the drop side can disengage from the crib, posing a fall and entrapment hazard. Additionally, the metal locking pins on the drop side can pop off, presenting a choking hazard. The crib was sold at department stores and children's product stores from August 2005 to May 2007.







Playskool Toddler "No Spill" Sippy Cups Recalled on July 19, 2007

Young children can chew through the plastic spout of the sippy cup, which can pose a choking hazard. The cups were sold at CVS stores nationwide from September 2006 to April 2007.



Matelasse Crib Bumpers Recalled on July 24, 2007.

The decorative stitching on the bumper's edge can come loose, posing an entanglement hazard to young children. The bumpers were sold at Pottery Barn Kids stores nationwide from February 2003 to June 2007.




Sleepi Crib Foam Mattresses Recalled on August 23, 2007

The crib mattresses are not properly sized, creating a gap, posing an entrapment hazard to young children. The mattresses were sold at juvenile product retailers nationwide and via the internet from September 2006 to May 2007.



Jubee Bunk Beds Recalled on September 4, 2007

The bunk beds do not comply with federal safety standards and have wooden side slat supports that can separate from the bed frame causing the upper bunk to collapse. The beds were sold at specialty furniture stores nationwide and on various websites from December 2004 to April 2006.



Single Post Swing Sets Made by BCI Recalled on September 25, 2007

The connection on the top beam of the swing set can break, causing the swing beam to collapse, posing a fall hazard to the user. A user or bystander also can be injured by the falling top rail. The sets were sold by BCI Burke or BCI Burke Company representatives from January 2000 to August 2007.



One million Simplicity Cribs Recalled on September 21, 2007

The recalled Simplicity crib models include: Aspen 3 in 1, Aspen 4 in 1, Nursery-in-a-Box, Crib N Changer Combo, Chelsea and Pooh 4 in 1. The recall also involves the following Simplicity cribs that used the Graco logo: Aspen 3 in 1, Ultra 3 in 1, Ultra 4 in1, Ultra 5 in 1, Whitney and the Trio. The drop side can detach from these cribs, which can create a dangerous gap and lead to the entrapment and suffocation of infants. The cribs were sold in department stores, children's stores and mass merchandisers nationwide from January 1998 to May 2007.



"Moderne" and "Loft" Cribs Recalled on September 4, 2007

The crib slats can separate from the side rails, posing an entrapment and strangulation hazard to young children. The cribs were sold at juvenile furniture stores nationwide from October 2003 to June 2005.



Kolcraft Play Yards Recalled on September 27, 2007

Twelve models of play yards are included in this recall. The play yards have a raised changing table with a restraint strap that forms a loop beneath the changing table, posing a strangulation hazard to a child in the play yard. In addition, one play yard also has a raised cradle that rocks back and forth. A child can roll and get trapped against the side of the cradle in the Contours 3-in-1 Play Yard. If that happens, a child can suffocate. The play yards were sold at retail stores nationwide from January 2001 to September 2007.



Frankenstein Tumblers Recalled on October 4, 2007

The tumblers have surface paint on the center of the eyes that contains high amounts of lead. The tumblers were sold at Dollar General stores nationwide in September 2007.



Alpine Design Aluminum Water Bottles Recalled on October 4, 2007

The surface paint on the water bottle contains high amounts of lead. The bottles were sold at Sports Authority from April 2006 to September 2007.



Starbucks Children's Plastic Cups Recalled on October 9, 2007

If the cup is dropped, the colorful face on the cup can break off and leave small parts or sharp exposed edges that can pose a choking or laceration hazard to young children. The cups were sold at Starbucks stores nationwide from May 2006 to August 2007.



Bumbo Baby Sitter Seats Recalled on October 25, 2007

If the seat is placed on a table, countertop, chair or other elevated surface, young children can arch their backs, flip out of the Bumbo seat, and fall onto the floor, posing a risk of serious head injuries. The seats were sold at Target, Wal-Mart, Sears, Toys R Us, Babies R Us, USA Babies, and various other toy and children's stores nationwide, and various online sellers from August 2003 to October 2007.



Wendy Bellissimo Collection Convertible Cribs Recalled on November 8, 2007

The bolts connecting the top corners of the crib can come loose, creating a gap and posing a serious entrapment and strangulation hazard. The cribs were sold at Babies R Us stores nationwide from July 2005 to October 2007.




Jetmax International "Home Trend Kids 9 Canvas Bin Boy's and Girl's Organizers" Wooden Storage Rack Recalled on November 16, 2007

The storage rack can tip over, posing an entrapment and suffocation hazard to young children. The racks were sold at Wal-Mart from August 2004 to July 2005 and Ollie's' stores nationwide from July 2006 to June 2007.



Slipcovers Used with Bobby Pillows Recalled on November 21, 2007

Three slipcovers have zippers that can break posing a choking hazard to young children. Those three slipcovers have color combinations as follows: blue/green velvet, pink/orange velvet, and pastel blue velvet. They were sold at discount department stores nationwide from July 2007 to September 2007.



Four slipcovers have paint on the zippers that contains high amounts of lead. Those four slipovers have color combinations as follows: pastel blue "Boa", bright pink velvet, navy blue velvet, and sage green velvet. They were sold at discount department stores nation-wide from February 2007 to September 2007.



Flashing Pacifiers Recalled on November 21, 2007

Flashing Pacifiers and 2-in1 Flashing Pacifiers with Whistle Necklaces have a nipple that can detach from the base, posing a choking hazard to young children. They were sold at various retail stores nationwide during July 2007.



First Years 3-in-1 Flush and Sounds Potty Seats Recalled on December 6, 2007

The decorative plaque inserted into the back of the potty seat could have orange paint that contains high amounts of lead. The seats were sold at mass and specialty retail stores nationwide from April 2006 to August 2007.



First Years Newborn-to-Toddler Reclining Feeding Seats Recalled on December 6, 2007

The restraining straps can pull out of the waist strap slots, posing a fall hazard. The seats were sold at various retail stores nationwide from November 2006 to October 2007.



Infantino Lion Teethers Recalled on December 13, 2007.

The plastic nose can detach, posing a choking hazard to children. The teethers were sold at Babies R Us, Pottery Barn Kids and other specialty stores nationwide from June 2006 to December 2007.



Bunk Beds Recalled on December 13, 2007

The bunk beds have gaps between parts of the upper bunk that could allow a child's body to pass through but not a child's head which poses an entrapment and strangulation hazard. The recalled beds come in twin-over-twin, twin-over-full and loft beds with the following model names: Albany Park, Swedish Accents, Mariner's Landing and Chelsea's Place. The bunk beds were sold at Hooker Furniture retailers nationwide from August 2005 to August 2007.

The snap closures on the jackets contain high amounts of lead. The jackets were sold in major department stores and discount department stores nationwide from October 2006 to November 2006.



Hooded Sweatshirts and Windbreakers Recalled on February 13, 2007

The garments have a drawstring through the hood, posing a strangulation hazard to children. The sweatshirts and windbreakers were sold at discount department stores nationwide from May 2003 to December 2006.



H & M Jackets with an Attached Compass Recalled on March 8, 2007

The attached compass on these jackets can break, posing a choking hazard for young children. Additionally, liquid mineral oil, inside the compass, can be harmful if swallowed. The jackets were sold at H & M stores nationwide from February 2006 through October 2006.



N-Kids Brand Girl's Drawstring Flannel Pants and Pine Peak Blues Brand Boy's Drawstring Flannel Pants Recalled on March 8, 2007

The garments fail to meet the children's sleepwear flammability standards. The pants were sold at Nordstrom's from July 2005 to December 2005.



Cobmex Youth Jackets with Drawstrings Recalled on March 8, 2007

The jackets have drawstrings at the waist and/or the hood. The drawstrings can catch on playground equipment, fences or tree branches, posing an entanglement and strangulation hazard for children wearing them. The jackets were sold at children's clothing and school uniform stores nationwide from January 2006 through February 2007.



Hanna Andersson Children's Loungewear Recalled on March 19, 2007

Hanna Andersson Children's Crossover Tee and Lounge Pant Sets and Cropped Johns fail to meet the children's sleepwear flammability standards. The clothing was sold in Hanna Andersson stores nationwide, and through the Hanna Andersson catalog and website from Summer 2004 through November 2006.



Disney Children's Footed Pajamas Recalled on April 17, 2007

The Baby Einstein Caterpillar Sleepwear and Baby Einstein Duck Sleepwear fail to meet the children's flammability standard, posing a risk of burn injury to children. The sleepwear was sold at Disney Stores nationwide from April 2006 through May 2006.









RedEnvelope Children's Sweatshirts with Drawstrings Recalled on April 17, 2007

Life is good Children's Sweatshirts have a drawstring through the hood, posing a strangulation hazard to children. The sweatshirts were sold at RedEnvelope.com from March 2006 through March 2007.

Payless Children's Clog Shoes Recalled on May 2, 2007 with an Expanded Recall Issued on July 17, 2007

Children's Airwalk Compel Shoes have plastic rivets used to attach the strap to the shoe which can detach, posing a choking hazard to young children. The shoes were sold at Payless ShoeSource and Pamida stores nationwide and Payless.com from January 2006 through June 2007.

Capri Pants Recalled on May 17, 2007

Little Girls Capri Pants with Snap Roll Cuff have buttons inside the waistband which can detach, posing a choking hazard to young children. The pants were sold exclusively at Mervyns stores nationwide from December 2006 through April 2007.

Boys' Three-Piece Short Sets Recalled on May 16, 2007

The Samara Brothers Three Piece Short Sets have decorative fish buttons on the shorts and shirt which can detach, posing a choking hazard. The sets were sold through major department and discount department stores nationwide from April 2006 through March 2007.



Gardening Gloves Recalled on May 16, 2007

The Troy-Bilt Budding Gardener Complete Gardening Set has a stamp-painted logo on the backside of the gardening gloves which contains high amounts of lead. The sets were sold at troybilt.com from February 2006 through January 2007.



Personalized Infant Long Johns Recalled on June 7, 2007

The Red Baby Long Johns have metal snaps which can loosen and detach, posing a choking hazard to young children. The long johns were sold through Personal Creations catalog and personalcreations.com from September 2006 through January 2007.



Party Hats Recalled on June 7, 2007

The First Birthday Party Hats by Creative Expressions have foil fringe glued to the bottom edge of the party hats which can detach, posing a choking hazard to young children. The hats were sold at party and discount department stores nationwide from February 2005 through May 2007.



Jeweled Sandals Recalled on June 14, 2007

The "Calypso" Sandals have jewel decorations on them which can detach, posing a choking hazard to young children. The shoes were sold at Nordstrom stores nationwide and on Nordstrom.com during February 2007.



Jackets Recalled on June 14, 2007

The Pine Peak Blues Children's Jackets have a zipper pull which can detach from the jacket's zipper, posing a choking hazard to young children. The jackets were sold exclusively at Nordstrom stores from November 2006 through April 2007.

Hanna Andersson Sandal Clogs Recalled on August 3, 2007

The Birchwood Sole Sandal Clogs by Hanna Andersson have a leather ankle strap which can tear or separate from the clog sole, posing a fall hazard. The shoes were sold through Hanna Andersson stores, catalog, and website nationwide from January 2007 through July 2007.



Girls' Clothing Sets Recalled on August 23, 2007

The Basic Editions-brand Girls' Clothing Sets by Kmart have drawstrings at the waist which can get caught in a vehicle door and cause the child to be dragged, posing a serious risk of injury or death. The shirts were sold exclusively at Kmart stores nationwide from March 2007 through May 2007.



Youth Hats Recalled on August 29, 2007

The toddler and youth Nylon Bucket Hats have a drawstring, posing a strangulation hazard to young children. The hats were sold exclusively at Bass Pro Shops retail stores nationwide from February 2007 through June 2007.



Hooded Sweatshirts with Drawstrings Recalled on August 30, 2007

The Zippity Hoodie and Sherpa Full Zip Children's Hooded Sweatshirts have a drawstring through the hood, posing a strangulation hazard to children. The sweatshirts were sold at Independent retailers in Boston and Chatham, Mass. and Flagstaff, Ariz. from July 2007 through August 2007.



Cub Scouts Totem Badges Recalled on October 9, 2007

The surface paint on the badges contains high amounts of lead. The badges were sold at Boy Scouts of America retail outlets nationwide from January 2000 through September 2007.



Payless Girls' Boots Recalled on October 18, 2007

The guitar-shaped zipper pulls on each boot can interlock while a child is walking, causing the child to trip and fall. The boots were sold at Payless ShoeSource stores nationwide and Payless.com from August 2007 through September 2007.



Bath Robes Recalled on November 15, 2007

The Bon-Ton Girls and Boys Bath Robes fail to meet the children's sleepwear flammability standard, posing a risk of burn injuries to children if the robe caught fire. The robes were sold by Bon-Ton, Bergner's, Boston Store, Elder-Beerman, Herberger's, Younkers, and Carson Pirie Scott stores nationwide and Parisian (Detroit area only) from September 2007 through October 2007.



Old Navy Boys' Jackets Recalled on December 3, 2007

The jackets have a waist drawstring with a toggle that could become snagged or caught in small spaces or doorways which can pose an entrapment hazard. The jacket was sold at Old Navy stores nationwide and on oldnavy.com from August 2007 to November 2007.



Full Zip Hooded Sweatshirts Recalled on November 27, 2007

The garments have a drawstring through the hood which can pose a strangulation hazard. The sweatshirts were sold at Bon-Ton, Bergner's, Boston Store, Carson Pirie Scott, Elder-Beerman, Herberger's and Younkers stores nationwide and Parisian stores in the Detroit area from August 2007 to October 2007.



TKS Children's Pants Recalled on December 6, 2007

The pants have a ribbon belt at the waist, which is longer than the maximum length set forth in the CPSC guidelines, and poses an entrapment and entanglement hazard. The pants were sold at Sears stores nationwide from July 2007 to August 2007.



Basic Editions Girls' Clothing Sets Recalled on December 6, 2007

The pants have a drawstring at the waist, which is longer than the maximum length set forth in the CPSC guidelines, and poses an entrapment and entanglement hazard. The pants were sold at Kmart stores nationwide during July 2007.



Personal Identity Sweaters Recalled on December 6, 2007

The sweaters have a drawstring through the hood that poses a strangulation hazard. The sweaters were sold at Sears stores nationwide during September 2007.



Hooded Sweatshirts Recalled on December 6, 2007

The garments have a drawstring through the hood which poses a strangulation hazard. The sweatshirts were sold at mass merchandise and specialty children's clothing retail stores nationwide from August 2007 to November 2007.



Sunglasses Recalled on December 7, 2007

The surface paint on the sunglasses contains high amounts of lead. The sunglasses may have the name "Foster Grant" on the temple arm. Fifteen styles have been recalled. The style names affected, which are printed on the inside of the left temple arm are Balloon, Bond, Boom, Bubble Gum, Bullseye, Buzz, Conqueror Jr., Curly Q, Encompass Jr. IK, Fade IK, Gadget IK, Iceman, Lily, Outer Space, and Pluto. The sunglasses were sold at various stores nationwide from January 2007 to November 2007.



Gap Outlet "Warmest Jacket" Boys' Jacket Recalled on December 27, 2007

The jackets have a waist drawstring with a toggle that could become snagged or caught in small spaces or doorways, which poses an entrapment hazard. The jacket was sold at Gap Outlet stores nationwide from September 2007 to December 2007.



Jewel Girls' Hooded Sweatshirts Recalled on December 21, 2007

The garments have a drawstring through the hood which can pose a strangulation hazard to children. The sweatshirts were sold at Marshalls and other specialty children's clothing retailers nationwide from August 2007 to November 2007.

ATVs & Bicycles

The following is a list of ATV and bicycle recalls issued between January 1, 2007 and December 31, 2007.



Arctic Cat Model Year 2007 90cc Youth Model ATVs Recalled on January 23, 2007

The handlebar base, mounting bolts, tie-rod ends and tie-rod adjustment locking nuts may not have been tightened to the proper torque during the production process. Operating an affected ATV could cause components to loosen resulting in loss of steering control. This condition could result in loss of vehicle control, which could result in injury or death. The recalled vehicles were sold at Arctic Cat dealerships nationwide from August 2006 to January 2007.



Long Chang Lion 90cc Youth Model ATVs Recalled on May 3, 2007

These ATVs by Stateside Powersports lack adequate tire labeling, tire pressure gauge, adequate stop engine switch and other safety requirements which could result in injury to consumers. The ATVs were sold at ATV dealerships and online nationwide from May 2006 through December 2006.



Warning Issued on Kazuma Meerkat 50 Youth ATVs on June 5, 2007

The Kazuma Meerkat 50 Youth ATV has multiple safety defects including no front brakes, no parking brake, and a missing neutral indicator light. It can also be started while in gear. Additionally, the owner's manual does not contain complete information on safe operation and maintenance of the ATV. The ATVs have been sold by Kazuma dealers and Web retailers nationwide since 2003.



Ohalee FA-A70 Youth ATVs Recalled on September 6, 2007

These youth ATVs lack front brakes and a tire pressure gauge, the date of manufacture is not printed on side of the tires, and the front suspension is solid and does not allow for travel. Additionally, the flag pole bracket is not the correct size, and the handlebars do not have padding covering sharp edges. The owner's manual does not contain complete information on the safe operation and maintenance of the ATV. These defects could result in an unsafe riding condition, posing a risk of injury to young drivers. These ATVs were sold by Odes Motorcycle Industry nationwide from June 2006 through December 2006.



Children's Trailer Bicycles Recalled on September 18, 2007

The Novara Afterburner Trailer Bicycles can detach from the adult bicycle, posing a fall hazard to children. The bicycles were sold at REI stores nationwide from February 2007 through June 2007.



Baja Youth ATVs Recalled on November 21, 2007

Three Baja Youth ATVs, the Baja 90, the Baja Wilderness 90 and the Baja Wilderness 90u lack a tire pressure gauge and flag pole mounting bracket, which poses a risk of injury to riders. The vehicles were sold at retail outlets, ATV dealerships, and online, nationwide from November 2004 to July 2007.



Specialized Bicycle Helmets Recalled on December 18, 2007

The helmets fail testing required under CPSC's safety standards for bicycle helmets. This can pose a head injury hazard to riders in a fall. The helmet was sold by Specialized Bicycles through its authorized retailers and online stores from July 2007 to October 2007.

What You Should Know About Exposure to Lead

What is lead?

• Lead is a metal that is found in many places. You can't always see lead, even when it's present in high amounts in substances like paint, dust or dirt.

What damage is done by lead?

- Lead in the body is not safe at any level. Even very small amounts of lead can permanently damage the brain as it develops. The only way to prevent damage from lead is to prevent exposure to lead.
- Lead makes it harder for a child to learn and causes behavior problems.
- Damage done by small amounts of lead may be hard to see. Most children who get lead in their body do not have any physical symptoms.

Where is lead found?

- Children are often exposed to lead in their own homes and at places they visit.
- Lead was added to paint until 1978. Most older homes have paint that contains lead. In the United States, lead is in paint in:
 - 87 percent of homes built before 1940,
 - 69 percent of homes built from 1940 to 1959 and
 - 24 percent of homes built from 1960 to 1977.
- Lead gets into dust and dirt. Children eat lead by getting lead on their hands and then putting their hands in their mouth.
- High amounts of lead in dust occur when paint is chipping or peeling or when paint is disturbed during repairs.
- Lead is sometimes found in toy jewelry and other products.


What can I do to protect my child?

- Learn if you have lead in your home. Before you sign a lease, ask the landlord about lead. Before you buy a home, have it inspected for lead.
 - If your home was built before 1978 or you don't know when it was built, assume it has lead.
- Painted surfaces should be kept in good repair. Do not disturb paint unless you and your family are protected from the dust that will occur during repairs. Repairs not done safely can make the problem worse. Learn how to protect your family before work begins by getting information from the sources below.
- Have your child's blood lead level checked. A blood lead test at 1 and 2 years of age is required for children who could be exposed to lead. Also, whenever new exposures to lead may have occurred, a blood lead test should be considered.
